iv)	10% of the meritorious students admitted under SC/ST/OBC	10% of the fee as Fellowship subject to the parental income not exceeding Rs.3,00,000/- per annum
v)	Children of GVP Employees	Fellowship of 15% from out of the prescribed fee for the employees whose income is less than Rs.6,00,000/- per annum and 10% for remaining

General Rules:

- Admission Fee: ₹25,000/- payable at the time of admission.
- Scholarships are offered for all the B.Tech. programs, based on merit.
- All Scholarships are applicable on Tuition Fee only.
- No student can avail more than one scholarship of any category.

Conditions for continuation of scholarship: For continuation of scholarship for subsequent years, one has to meet the following,

- student must maintain a minimum attendance of 85% in all subjects
- have to pass all the subjects in the first attempt.
- student must maintain a minimum of:
 - 9.0 CGPA in B.Tech (CSE/ CSM/ CSD / ECE / CSC &IT)
 - 8.5 CGPA in B.Tech (ME/ CE / EEE / Chemical)
- in case of malpractice or indiscipline, the student will forfeit the scholarship/concession from the semester in which the student incurs the backlog.
